This year's theme asked each artist to create a work that involved the idea of breaking a personal or cultural rule. The resulting exhibition generates a space that questions the social role of the artist in regard to establishing and/or challenging cultural norms, as well as the artist's personal relationship to that role within their own artmaking practice.



As a figure in cultural discourse, how does the artist function to critique or envision the world differently? How do the rules set up by an artist in their personal practice enable them to
